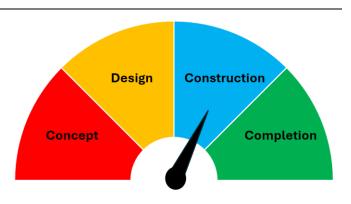
Clear and transparent communication ensures that all stakeholders, including school board members, administrators, teachers, parents, and community members, are well-informed about project goals, timelines, and progress. This level of awareness fosters trust and promotes collaboration, which are essential for navigating challenges and making informed decisions that best serve students.

Engagement provides opportunities for stakeholders to share input, voice concerns, and stay involved throughout the project. Actively involving the school community helps align construction efforts with the educational mission and priorities of the district, ensuring that facilities are designed to support student learning, safety, and well-being.

Capital Project Phases

Concept Planning: This phase involves initial project discussions and evaluations to determine feasibility, aligning the scope with available budget, and establish goals and a strategic vision. It includes assessing needs, exploring options, and laying the groundwork for successful execution. Preliminary designs and engineering studies may also be developed to support decision-making. Communication with PCSD departments as well as the school



principal also occurs in the Concept Planning phase to ensure the best possible outcome with the budget available. This phase also involves communication with the GaDOE regarding facility planning and GSFIC reimbursement processes.

Design and Procurement: In this phase, an architectural firm and construction manager are engaged to create detailed architectural and engineering plans from the assigned scope, make professional recommendations, and finalize specifications. The procurement process follows, involving market solicitation, evaluation of bid proposals, and making final selections of contractors and suppliers to prepare for construction. This stage ensures that all resources and partners are secured for the next steps.

Construction: Working with the architectural firm and construction manager, a construction contract is executed, sometime including a Guaranteed Maximum Price (GMP). The construction manager then oversees the actual construction process, bringing project plans to life. The construction manager coordinates labor, materials, costs, and timelines to ensure the project remains on schedule and within budget while maintaining high quality standards. Safety of our students and staff is the number one priority during this phase.

Completed: A project is considered complete once a certificate of occupancy is issued by the local authority. After major construction concludes, minor deliverables are addressed, and the project undergoes final quality checks and approval. This phase ensures all work is finished as specified, and the facility is ready for use, meeting all safety and functional requirements.



Active Capital Projects

Active Capital Projects are major capital improvement initiatives in the construction phase, categorized as New Construction, Additions, Renovations/Modifications, and Other. In this phase, a construction contract has been executed, and the construction manager is actively overseeing the building process, coordinating labor, materials, costs, and timelines to ensure the project remains on schedule and within budget.

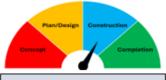

Upcoming Capital Projects Highlights

Elementary School #20

Project Description: The next elementary school to be built in Paulding County will be located adjacent to the newly constructed Crossroads Middle School on the Seven Hills Connector. The project will assist with balancing enrollment at several schools located in the North Paulding area. This project is part of SPLOST VII which was approved by voters in November 2023. Collections for SPLOST VII will begin in May 2025.

Timeline: The design phase for ES #20 began in April 2024. This project is scheduled to begin in June 2025 and the school should open in August 2026.

Estimated Cost: \$34 million

South Paulding High School Renovation/Modification

Project Description: Renovation and Modification projects refresh the school's systems and finishes. Partial funding by the GA DOE Capital Reimbursement Program reduces cost impact to PCSD. While the scope of each renovation project can differ, typical renovation projects include new flooring, gym floor refinishing, painting, new HVAC, fire alarm, intercom, LED lighting, and plumbing upgrades. The design also anticipates modifications to the weight room.

Timeline: The design phase for South Paulding High School renovations is underway. The construction phase of the project will begin in January 2026 and will be completed over two summers (2026, 2027)

Estimated Cost: \$13.5 million

High School Multi-Purpose Buildings

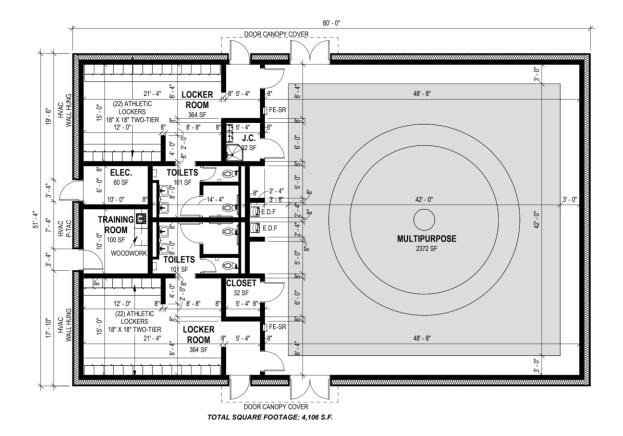
Project Description: To provide additional classroom space within the buildings, additional locker room space for females and males, and to provide access to sports medicine at our high schools, multi-purpose buildings are being added to Hiram HS, North Paulding HS, Paulding County HS, and South Paulding HS. Additionally, renovations will be made to the East Paulding Fieldhouse to provide adequate female locker room facilities.

Timeline: This project is part of SPLOST VII which was approved by voters in November 2023. These buildings are currently in procurement. The projects are set to begin in May 2025 and completion is anticipated by December 2025,

Estimated Cost: \$5.1 million

Future Capital Projects

Future Capital Projects are major capital improvement initiatives in the Concept Planning phase, categorized as New Construction, Additions, Renovations/Modifications, and Other. This phase involves initial project discussions and evaluations to determine feasibility, define the scope, and establish goals and a strategic vision. It includes assessing needs, exploring options, and laying the groundwork for successful execution.

Elementary School #21

An elementary school located in the southern region of the county is currently in concept phase. Elementary school #21 would have an impact to both Union Elementary and New Georgia Elementary enrollment. Community feedback meetings will be scheduled for Spring 2025.

Turf Fields and Athletic Lighting

An Athletic Facilities study was completed in 2023 as part of development of a <u>Facilities Master Plan</u>. The study identified that stadium turf fields are approaching end of life and would require replacement to maintain field integrity and safety. Additionally, lighting at athletic fields on all five high school campuses were noted for upgraded lighting. These projects are currently in concept planning. These projects are part of SPLOST VII which was approved by voters in November 2023. Collections for SPLOST VII will begin in May 2025.

Additional Renovation/Modification Projects

The timing of school renovation projects that refresh the school' systems and finishes are determined through a building conditions study as part of the <u>Facilities Master Plan</u>. Renovation projects also align with school funding reimbursement eligibility through the GA DOE Capital Reimbursement Program. The following schools have been identified for renovations and reimbursements over the next several years:

Irma Austin Middle School Dallas Elementary School Connie Dugan Elementary School Sammy McClure Middle School W.C. Abney Elementary School

Miscellaneous Capital Projects

Miscellaneous Capital Projects are capital improvement initiatives of a smaller scope than New Construction, Additions, and Renovations/Modifications. These projects are in various stages and may be implemented over several years as funding become available.



Fine Arts

Auditoriums at all five high schools will receive replacement stage curtains and upgrades to the sound and lighting systems. The stage curtains are planned to be a replaced similar to the original specification. Several changes to the lighting and sound system specifications are being recommended to support of the types of presentations that are being produced today.

The solicitation is being finalized for public advertisement after winter break and scheduled for delivery in time for the 2025-26 school year.

Capital Projects Fund Activity and Procurement Status

The **Capital Projects Fund** accounts for and reports financial resources including Education Special Purpose Local Option Sales Tax (E-SPLOST), bond proceeds and grants from Georgia State Financing and Investment Commission (including the State Capital Outlay Program) that are restricted, committed or assigned for capital outlay expenditures, including the acquisition or construction of capital facilities and other capital assets. Reflects funds 300 - 399.

Special Purpose Local Option Sales Tax for education (E-SPLOST), a one-cent sales tax to help fund capital improvements and debt repayment, is the primary funding source for capital projects, in addition to various state grants, including the State Capital Outlay Program. E-SPLOST accounts for the majority of Capital Projects Fund activity and is highlighted below.
